**2.01 PURPOSE AND AUTHORITY.** (1) The purpose of this ordinance is to achieve greater efficiency and economy in the enforcement of certain county ordinances and to guarantee the fairness and consistency of enforcement procedures.

(2) This chapter is created pursuant to the authority granted by sec. 66.0113, Wis. Stats. The county hereby elects to use the citation method of enforcement of certain ordinances other than those for which a statutory counterpart exists.

(3) Nothing contained in this chapter shall be construed to prevent the use of any other method of enforcing Dane County Ordinances including, but not limited to, the use of a summons and complaint under chapters 66 and 299, Wis. Stats.

**2.04 CONTENTS OF THE STANDARD CITATION.** Citations issued pursuant to this ordinance shall provide for the following:

- (1)** The name and address of the alleged violator.
- (2)** Factual allegations describing the alleged violation.
- (3)** The time and place of the offense.
- (4)** The section of the ordinance violated.
- (5)** A designation of the offense in such manner as can be readily understood by a person making a reasonable effort to do so.
- (6)** The time at which the alleged violator may appear in court.
- (7)** A statement which in essence informs the alleged violator:
  - (a)** That a cash deposit based on the schedule established by this chapter may be made which shall be delivered or mailed to the Dane County Clerk of Courts prior to the time of the scheduled court appearance;
  - (b)** That if a cash deposit is made, the alleged violator need not appear in court unless subsequently summoned;
  - (c)** That if a cash deposit is made and the alleged violator does not appear in court, the nonappearance will be deemed a plea of no contest for which a forfeiture not to exceed the amount of the deposit is submitted, or, if the court does not accept the plea of no contest, a summons will be issued for the alleged violator to appear in court to answer the complaint; and
  - (d)** That if no cash deposit is made and the alleged violator does not appear in court at the time specified, an action may be commenced to collect the forfeiture up to the maximum permitted by law.
- (8)** A direction that if the alleged violator elects to make a cash deposit, the statement which accompanies the citation shall be signed to indicate that the statement required under sub. (7) above has been read. Such statement shall be sent or brought with the cash deposit.
- (9)** In the event that the name and/or address of any particular alleged violator cannot be obtained under the circumstances, other identifying information, such as vehicle license number, may be utilized in lieu of the name and address. The last registered owner of record shall be presumed to have authorized the parking of any vehicle registered to him or her and as such shall be liable for any forfeiture imposed under this ordinance or any other ordinance of Dane County.

**2.05 FORM OF CITATION.** The form of the citation used under this chapter shall be approved by the judiciary committee, such approval to be recorded in said committee's minutes.

## **2.065 BAIL PROVISIONS SUBJECT TO STATE LAW FOR JUVENILES.**

Where the bail amounts set forth in s. 2.06 provide for greater penalties for juveniles than that established by state law, s. 2.06 shall for each violation be interpreted in the case of juvenile offenders to provide for the maximum penalty allowable under state law and such maximum penalty is hereby adopted as the bail amount for that violation.

**2.07 PROCEDURE. (1)** The provisions of sec. 66.119(3), Wis. Stats., relating to violator's options and procedure on default are hereby adopted and incorporated herein by reference.

**(2)** Receipts shall be given for all cash deposits.

**2.08 NONEXCLUSIVITY.** Adoption of this chapter in no way precludes the adoption of any other ordinance providing for the enforcement of any law or ordinance relating to the same of any other matter. The issuance of a citation under this chapter in no way precludes proceeding under any other law or ordinance relating to the same or any other matter.
